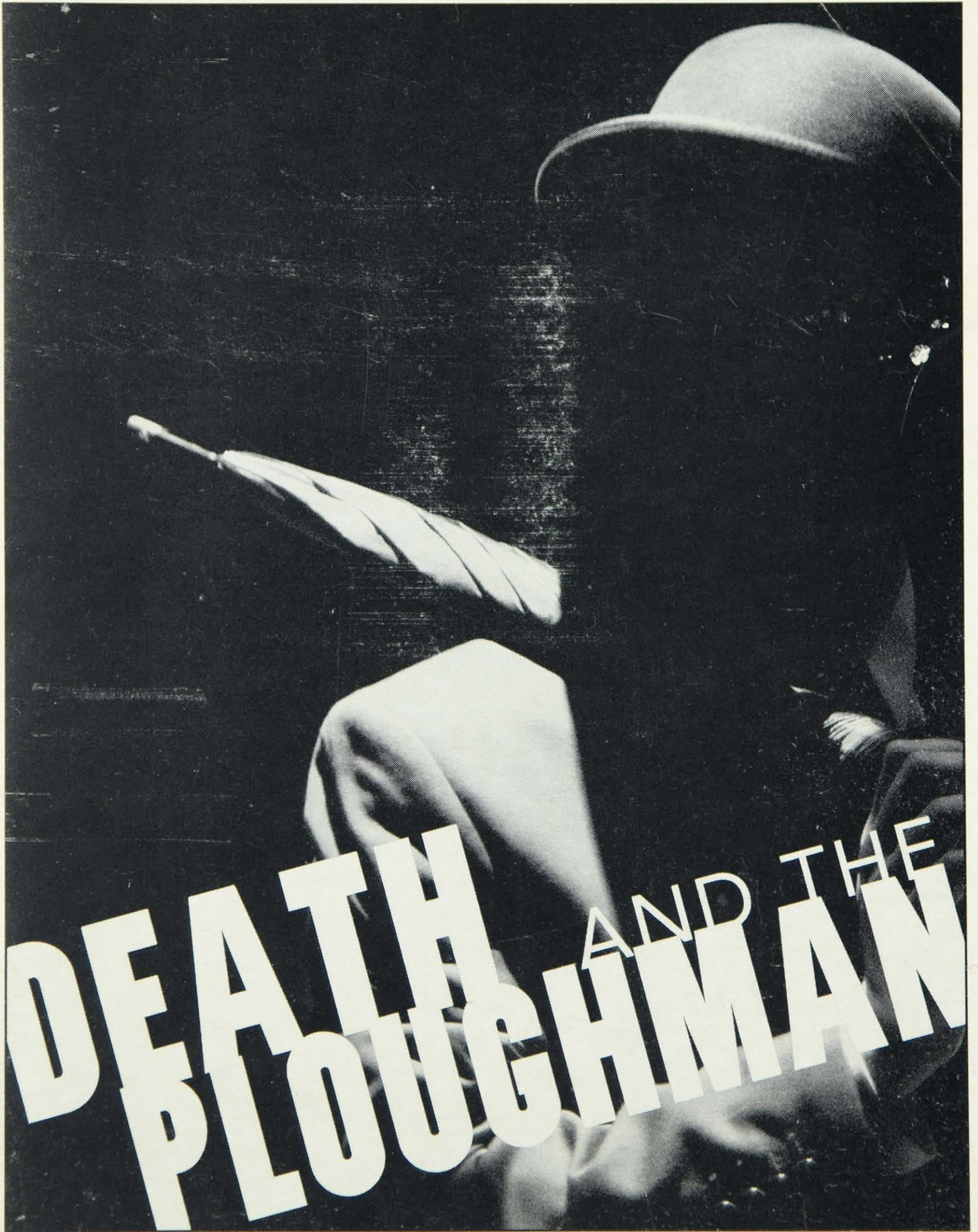

## DIRECTOR'S NOTE

I encountered *Death and the Ploughman* at the tiny Gate Theater in London two years ago and it stopped me in my tracks. The profundity and continued relevance of this text, written in 1401 in German in Bohemia at a paradigm-shifting moment in human history, is a remarkable human achievement. It was written at a time when the theretofore accepted medieval sensibilities were suddenly called into question—faith, the meaning of life, religious hierarchy, authority—leading to the start of the Renaissance.

Today we are undergoing another paradigm shift where religion, values and meaning must be examined from fresh new angles. This play by Johannes von Saaz can be a great help to us now. Irish playwright Michael West's adaptation of *Death and the Ploughman* brings an extraordinary grace, lightness and eloquence that feels very contemporary and relevant to our present world environment. Listen closely and be transformed.

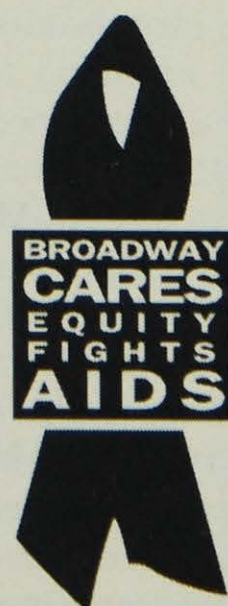
