All uses of flame are by means of 3 Zippo lighters which 3 actors use. The action is similar to lighting a cigarette, except there is no cigarette to light. The set is minimal, with only 2 tables, 8 chairs, and a small drop (flame retardant muslin) upstage. The drop will be painted, and necessary additives to make the paint flame retardant will be used.

The 8 chairs are found antiques, which we will seal with MG-110 (varnish) from Rosebrand. They are wood / metal antique folding chairs of various designs.

The tables are modern manufactured wood and steel construction and will also be sealed with MG-110 (varnish) from Rosebrand.

#1: At the beginning of the show, an actor lights a Zippo lighter centerstage. He walks approximately 12 feet and then closes the lid on the lighter, extinguishing it. It is lit for 10-15 seconds. He wears a wool sweater vest, a cotton button down shirt, a wool coat, wool trousers, and wool cap. He is not near any scenic elements or other actors.

#2: About a minute later, an actor stands upstage left about 3 feet from the drop and lights his lighter for a moment, 2-3 seconds. He closes the lid to extinguish it. He is stationary while the lighter is lit. He wears a wool suit and cotton shirt.

#3: About 8 minutes into the show, an actor (same as #2) standing approximately 25-30 feet from the edge of the stage lights a Zippo lighter for approximately 10 seconds. He closes the lid to extinguish it. He is stationary while the lighter is lit. He wears a wool suit and cotton shirt. He is not near other actors or scenic elements.

#4: About 50-55 minutes into the show, the same actor as in #2 & #3 stands approximately 20-25 feet from the edge of the stage and lights a Zippo lighter for approximately 15 seconds while stationary. He closes the lighter lid to extinguish it. He wears a wool suit and cotton shirt. He is not in close proximity to other actors or set pieces.

#5: About a minute after #3, another actor lights a Zippo lighter approximately 20 feet from the edge of the stage and walks toward the edge of the stage for about 10 seconds / 12 feet. He arrives in front of another actor who blows out the flame. The actor carrying the lighter wears a wool suit and cotton shirt. The actress who blows out the flame wears a wool blazer, silk shirt, and wool pants. She has short hair (1-2 inches long). She is sitting on top of a painted wood table.

#6: About a minute after #4, another actor (the same as in #1) lights a Zippo while seated in a wooden folding chair. He sits at a painted wood table. His lighter is lit for approximately 15 seconds. He extinguishes the flame by closing the lid of the

lighter. He wears a wool sweater vest, a cotton button down shirt, wool trousers and wool cap.





TOPICAL SEALANTS


Effective by coating substrates, making an FR barrier between the substrate and the source of ignition, such as with back-painting scenery. Since the substrate itself may not be previously treated and remains untreated throughout, some fire marshals may not accept topical treatment for temporary decorative and scenic materials, although most do. Topical treatments almost never are acceptable by code for permanent construction materials.

Paint additives will not change opacity or color of paint and sealants or change the coverage. They are ideal for non-porous substrates, untreated wood products, or previously painted scenery. Add to a clear acrylic glaze to create an FR sealant. Each yields a "Class A" rating to your coating.
